

WorldStrides 2023 Soccer Photo and Video Competition - Terms and Conditions

1. To enter this competition entrants are required to submit a photo or video taken of a soccer moment. Entrants will be required to submit their entries via an online submission portal where they will also have to submit their personal details including their name, school name, address, email address and the photo/video location.
2. This competition is open to students in Years 6-12 who took a photo/video of a soccer moment between 1/1/2023-31/10/2023
3. By entering the competition, entrants agree to abide by these Terms and Conditions.
4. The Terms and Conditions of this competition are governed by the laws of the State of Victoria.
5. The competition is being run by WorldStrides at 264 Keilor Road, Essendon North, Victoria, 3041.
6. The competition is called the "WorldStrides 2023 Soccer Photo & Video Competition" and commences at 9am Australian Eastern Standard Time (AEST) on Monday 4/9/2023.
7. The closing time for entering the competition is 5pm AEST on Tuesday 31/10/2023.
8. Entry to the competition is limited to Australian residents only. Prizes will not be shipped overseas.
9. Entrants under the age of 16 years must obtain parental consent to enter the competition and must declare on the Competition's online entry form that he or she has his or her parent's or guardian's consent to enter the Competition.
10. Photos can be submitted to one category:
 - a) Photo Category: Submit your best photo moment in soccer for 2023.
11. Videos can be submitted to one category:
 - a) Video Category: Submit your best video moment in soccer for 2023.
12. There are no limits on how many photos or videos you can submit to each category.
13. Entrants can only win one grand prize category.
14. Photos and videos that are submitted in connection with the contest will only be eligible if they:
 - a) Feature the entrant.
 - b) Are in colour.
 - c) Are submitted during the contest period.
 - d) Contain only "Original Content" of the entrant. "Original Content" means photos and/or videos that are created by the tour participant, and not photos and/or videos that have been created, produced, or edited by another party. WorldStrides will consider only those Photographs and Videos that meet all of these criteria, in the sole discretion of WorldStrides. WorldStrides reserves the right, in its sole discretion, to disqualify Photographs or Videos which it determines at any time in its sole judgment to fail to meet any of these criteria.
 - e) Entrants must obtain consent from all parties included in the submitted photo or video.
 - f) Do not contain any inappropriate behaviour, unlawful activity, drinking, nudity or swearing, in the WorldStrides' sole discretion.
 - g) Must use music legally. Students can create their own music, get written permission from the artist or sample free music.
15. The winner of the photo grand prize category will receive a \$250 Rebel Sports Voucher
16. The winner of the video grand prize category will receive a \$250 Rebel Sports Voucher
17. Entry to the competition is free. Entrants will be responsible for all costs associated with entering the competition, which may include costs associated with accessing the internet.
18. The team at WorldStrides will select photo and video finalists from each category based on image composition, resolution and overall quality, candidness, significance of content, originality, creativity, and overall presentation.
19. Prize winners will be chosen by WorldStrides' team of creatives, based on image composition, image resolution and overall quality, candidness, significance of content, originality, creativity, and overall presentation.
20. Other technical judging criteria for video include – simple editing, no excessive zooming or transitions, no shaky footage, clear and engaging audio without background noise, only one aspect ratio and orientation - must be either portrait 9:16 ratio or landscape 16:9 or 3:2 also accepted.
21. The prize winner will be contacted by Tuesday 7 November at the email address supplied by the entrant on the entry form.
22. If the prize winner does not respond to claim the prize within fourteen (14) days of the selection, a re-selection will be conducted within twenty one (21) days of the original selection date, in the same location, and with the same method. Re-selection will continue in the same manner until all prizes have been claimed by prize winners.
23. The prize may be collected in person by the prize winner or may be mailed/couriered.
24. If a prize winner who has been contacted and been made aware of their prize winning and has agreed to collect the prize or for which collection is the only method for receiving the prize, does not collect the prize within twenty-one (21) days of this contact, a re-selection will be conducted within thirty (30) days of the original selection date through the same method.
25. The prize winner may be required to provide evidence of their identity (such as photographic ID, birth certificate or current passport) when receiving the prize.
26. The prize is not transferrable.

27. The prize winner's name will be published on WorldStrides Social Media pages (Instagram, Facebook and LinkedIn). By entering the competition, entrants grant WorldStrides permission to use their full name on Social Media.
28. Entry into the competition signifies acceptance of all conditions. Entrants are required to abide by the Terms and Conditions as presented.
29. Entry into the competition signifies acceptance of all conditions by the parent or guardian on behalf of entrants under the age of 16. The awarding of the winning entry to an entrant under the age of 16 is subject to confirmation of parent or guardian consent to these terms and conditions.
